**Item 1.01 Entry into a Material Definitive Agreement.**

On January 16, 2009, Proliance International, Inc. (the Company ) entered into the Sixteenth Amendment (the Sixteenth Amendment ) of the Credit and Guaranty Agreement (as amended prior to January 16, 2009, the Agreement ) by and among the Company and certain domestic subsidiaries of the Company, as guarantors, the lenders party thereto from time to time (collectively, the Lenders ), Silver Point Finance, LLC ( Silver Point ), as administrative agent for the Lenders, collateral agent and as lead arranger, and Wells Fargo Foothill, LLC ( Wells Fargo ), as a lender and borrowing base agent for the Lenders.

Pursuant to the Sixteenth Amendment, and upon the terms and subject to the conditions thereof, the reduction of the Southaven Insurance Proceeds Reserve from \$5,000,000 to \$2,500,000, contained in Section 2.23 of the Agreement, has been extended from January 20, 2009 to February 6, 2009. In addition, the requirement in Section 5.13 of the Agreement to have interest rate protection by January 31, 2009, was extended to February 27, 2009.

The foregoing description of the Sixteenth Amendment does not purport to be complete and is qualified in its entirety by reference to the Sixteenth Amendment, a copy of which is filed as Exhibit 10.1 hereto, and incorporated herein by reference.
