The common stock was acquired by the Lenovo Group Limited ("Lenovo") through its indirect wholly-owned subsidiary, Lenovo IT Alliance Limited ("Lenovo IT Alliance") as partial consideration for the sale by Lenovo of its non-telecom related IT services business to (1) AsiaInfo Holdings, Inc. (the "Issuer") pursuant to an Acquisition Agreement, dated as of July 27, 2004, by and between Lenovo and the Issuer, as supplemented and amended by Supplement and Amendment No. 1 to Acquisition Agreement, dated October 1, 2004, by and between Lenovo and the Issuer (as amended, the "Acquisition Agreement").

The common stock was acquired by the reporting person upon the settlement of a Forward Contract, dated as of October 19, 2004, by and between Bonson Information Technology Limited, a direct wholly-owned subsidiary of the Issuer, and Lenovo IT Alliance (the "Forward Contract"), which Forward Contract was executed pursuant to the terms provided for in the Acquisition Agreement. The common stock was delivered by the Issuer in settlement of the Forward Contract on July 1, 2005.

(3) The common stock is held directly by Lenovo IT Alliance, which is a wholly-owned subsidiary of Lenovo Sysware Limited, which is a wholly-owned subsidiary of Lenovo Holdings (BVI) Limited, which is a wholly-owned subsidiary of Lenovo Group Limited.
