**Item 2.02. Results of Operations and Financial Condition.**

The following information is furnished under Item 2.02, Results of Operations and Financial Condition. On January 27 2005, United Defense Industries, Inc. issued a press release announcing certain financial and operating results for the fourth quarter of 2004. The press release and financial tables include non-GAAP financial information. Free cash flow, which is defined as net cash from operating activities less net capital spending, is included because management believes that free cash flow is the best indicator of discretionary cash available to management to pay down debt or make acquisitions or distributions and is therefore useful to both management and investors. Free cash flow is reconciled to net cash from operating activities in the financial tables accompanying the press release. The press release also announces that the company is authorized to repurchase an additional \$100 million in stock under its existing stock buyback program and that the board of directors has authorized a quarterly dividend payment of \$0.125 per share. The initial dividend payment will be made on March 1, 2005 to holders of record on February 15, 2005. A copy of the press release is filed as exhibit 99.1 hereto and is incorporated into Item 2.02 of this Form 8-K by reference.
