**SCHEDULE 13G/A**

This Amendment No. 1 to Schedule 13G (the "Schedule 13G") is being filed on behalf of Sapling, LLC, a Delaware limited liability company ("Sapling"), Fir Tree Recovery Master Fund, L.P., a Cayman Islands exempted limited partnership ("Fir Tree Recovery") and Fir Tree, Inc., a New York corporation ("Fir Tree"), relating to common stock (the "Common Stock") of Argyle Security Acquisition Corporation, a Delaware corporation (the "Issuer"), purchased by Sapling and Fir Tree Recovery. Fir Tree Value Master Fund, LP, a Cayman Islands exempted limited partnership ("Fir Tree Value"), is the sole member of Sapling, and Fir Tree is the investment manager of both Sapling and Fir Tree Recovery.

- (a) Sapling and Fir Tree Recovery are the beneficial owners of 200,241 shares of Common Stock and 92,735 shares of Common Stock, respectively. Fir Tree may be deemed to beneficially own the shares of Common Stock held by Sapling and Fir Tree Recovery as a result of being the investment manager of Sapling and Fir Tree Recovery.
- (b) Sapling and Fir Tree Recovery are the beneficial owners of 4.2% and 1.9%, respectively, of the outstanding shares of Common Stock. Collectively, the Reporting Persons beneficially own 292,976 shares of Common Stock which represent 6.1% of the shares of Common Stock outstanding. These percentages are determined by dividing the number of shares beneficially held by 4,781,307, the number of shares of Common Stock issued and outstanding as of November 10, 2006, as reported in the Issuer's Form 10-Q filed with the Securities and Exchange Commission on November 14, 2006.
- (c) Sapling may direct the vote and disposition of 200,241 shares of Common Stock. Fir Tree Recovery may direct the vote and disposition of 92,735 shares of Common Stock. Fir Tree has been granted investment discretion over the shares of Common Stock held by Sapling and Recovery.
