This Amendment No. 5 amends the Schedule 13D filed by Richard L. Scott (the Reporting Person ) on April 12, 2004 (the Schedule 13D ), as amended on May 27, 2004, July 6, 2004, November 21, 2006, and January 10, 2007 with respect to shares of Common Stock, \$.001 par value ( Common Stock ), of Media Sciences International, Inc., a Delaware corporation (the Issuer ). Capitalized terms used but not defined herein shall have the same meanings ascribed to such terms in the Schedule 13D.

The following Items are hereby amended as follows:

**Item 5. Interest in Securities of the Issuer**

- (a) The 1,036,050 shares of the Common Stock owned by the Reporting Person constitute 9.2% of the outstanding Common Stock of the Issuer based on the outstanding shares of Common Stock set forth in the Issuer's most recent Form 10-QSB.
- (b) The Reporting Person has sole voting and dispositive power with respect to the Common Stock.
