- (1) New account as of December 2001 - Shares held in Trust pursuant to Directors Deferred Compensation Plan - a 16b-3 Plan. Report of transactions completed by Trustee on November 7, 2002.
- (2) Balance held in Trust pursuant to Directors Deferred Compensation Plan - a 16b-3 Plan. Report of transactions through September 2002. As of December 13, 2001, began 10-year distribution, per director's election. A total of 8,342 shares were distributed, each distribution of 4,171 shares, on December 13, 2001 and June 28, 2002, respectively, representing about two-tenths of the total 41,717 shares to be distributed. These shares have been previously reported on Section 16 filings. The descending balance will continue to be held by the trust through the 10-year distribution period.
- (3) Adjusted to reflect the 8,342 shares described in footnote (2), now held directly.
