Restricted stock units convert into common stock on a one-for-one basis. Accordingly, there was no purchase price paid by the reporting person.

- (2) On September 16, 2016, 723 shares of United Natural Foods, Inc. (the "Company") restricted stock units vested. The Company retained 242 shares on that date to satisfy certain tax withholding obligations in connection with the vesting.
- (3) On September 17, 2016, 900 shares of United Natural Foods, Inc. (the "Company") restricted stock units vested. The Company retained 301 shares on that date to satisfy certain tax withholding obligations in connection with the vesting.
