AWM also serves as the general partner of MGP Advisers Limited Partnership ("MGP"), the general partner of and investment adviser to Special Situations Fund III, L.P. ("SSF3"). (SSF3 and Cayman will hereafter be referred to as, the "Funds"). The principal business of each Fund is to invest in equity and equity-related securities and other securities of any kind or nature.
