Rio de Janeiro, November 06, 2014 – Vale S.A. (Vale), within a process of simplifying its corporate structure, proposed the merger of Vale's wholly-owned subsidiaries Sociedade de Mineração Constelação de Apolo S.A. e Vale Mina do Azul S.A., which were approved by the Board of Directors today.

Therefore, the proposal will be submitted to the approval of Vale's shareholders at a meeting to be announced opportunistically.
