On June 4, 2018, the Company announced the closing of a combination transaction involving the Company and Champion Enterprises Holdings, LLC (Champion). In connection with the closing, the Company issued a number of newly-issued shares of Common Stock of the Company to Champion in an amount sufficient such that, immediately following such issuance, the shares of Common Stock of the Company held by the shareholders of the Company immediately prior to such transaction represented approximately 15.5% of the outstanding Common Stock of the Company. As a result of such transaction, (a) the number of shares of Common Stock of the Company held by the Reporting Persons represents less than five percent (5%) of the total outstanding shares of Common Stock of the Company, and (b) the Reporting Persons are no longer

subject to reporting obligations under Section 13 of the Securities Exchange Act with respect to their holdings of Common Stock of the Company. The filing of this Schedule 13G/A constitutes an exit filing for the Reporting Persons.
