Due to the resignation of our previous independent registered public accounting firm on November 26, 2012 and the delay involved in retaining a new independent registered public accounting firm on November 29, 2012, the Registrant was unable to commence certain year-end financial statements and other processes until late November 2012 and, as a result, the Registrant was unable to complete its Annual Report on Form 10-K for the fiscal year ended September 30, 2012 within the prescribed period without undue hardship and expense.
