Pursuant to a Purchase Agreement dated December 17,2007, TGR Capital, LLC (which changed its name to Enerfund, LLC in September 2008), a Florida limited liability company ("Enerfund"), which is wholly- owned by Mike Zoi, acquired all of the membership interests in

- (1) Splinex LLC, thereby giving Enerfund control of Splinex LLC. Under an Exchange Agreement dated December 18, 2007, TOT Energy, Inc. ("the Compnay") issued 113,500,000 shares of the Company to Splinex LLC of which 8,500,000 shares were issued to Bzinfin S.A., a British Virgin Islands limited liability Company. In June 2008, Splinex, LLC changed its name to TGR Energy, LLC ("TGR").
- Pursuant to a Subscription Agreement dated August 7, 2008, as amended on December 6, 2009, between TGR and the Company (the "Subscription Agreement"), for the quarter ended September 30, 2010, TGR was issued 2,240,450 shares of common stock of the Company and fully vested warrants to purchase 1,120,225 shares of common stock of the Company exercisable at \$0.05 per share in exchange for funding of \$44,809 provided during the quarter under the terms of the Subscription Agreement.
