- 2000 Stock Incentive Plan: Includes 32,208.23 restricted shares awarded pursuant to H.B. Fuller Company's 2000 Stock Incentive Plan. Amounts include 2678 restricted shares which will vest in four equal annual installments beginning on 4-15-05, 15,844 restricted shares
- (7) which will vest effective December 2, 2007 and 14,366 restricted shares which will vest effective December 1, 2008. Total amount also includes restricted shares acquired pursuant to a dividend reinvestment feature of the 2000 Stock Incentive Plan. All holdings changed to reflect August 4, 2006 2:1 stock split.
