 - (1) Includes 3,712 restricted stock units (RSUs) mandatorily deferred by the Company from Mr. Derechin's annual discretionary bonus, plus 928 RSUs granted to Mr. Derechin as a company match on his mandatory bonus deferral. These RSUs will generally vest on the third anniversary of grant. Also includes 4,950 RSUs voluntarily deferred by Mr. Derechin from his annual discretionary bonus, plus 1,237 RSUs granted to Mr. Derechin as a company match on his voluntary bonus deferral. These RSUs generally will be delivered on the third anniversary of grant. Also includes 24,870 RSUs that vest one-fifth ratably on each of January 27, 2007, 2008, 2009, 2010 and 2011.
