Item 1.01 Entry into a Material Definitive Agreement.

On May 4, 2005, Blockbuster Inc. ("Blockbuster") entered into a First Amendment (the "First Amendment") to the Credit Agreement dated as of August 20, 2004, among Blockbuster, the lenders from time to time parties thereto and JPMorgan Chase Bank, N.A., as administrative agent and collateral agent for such lenders. Pursuant to the First Amendment, Blockbuster's obligations with respect to maintaining a minimum fixed charge coverage ratio and a maximum leverage ratio were amended for the second, third and fourth quarters of 2005 for the fixed charge coverage ratio and for the second and third quarters of 2005 for the leverage ratio. A copy of the First Amendment is attached hereto as Exhibit 10.1 and is incorporated herein by reference.
