1. Will current US Airways employees who previously worked at American keep their previous American Airlines employee numbers and will they receive seniority credit for the time spent with American?

We're still early in the merger process, and employee numbers and decisions regarding seniority credit have not been determined.

2. How will the Reservations department be structured for the new American? Will it be office-based or home-based?

We will address decisions regarding reservations integration, including OBR and HBR status, once that process begins for the ARP workgroup. At this point it is too early to provide any specifics.

3. Are employees previously-separated from the company eligible to Travel on US Airways as part of the Interim Reciprocal Travel Program?

Employees who took a separation package (Voluntary Early Out, Stand in Stead, etc.) are not eligible for travel on US Airways. Travel privileges for separated employees are valid on any of the carriers in the AMR Network which presently includes American/American Eagle, SkyWest or ExpressJet flights marketed as American Eagle, and Chautauqua flights marketed as American Connection.

4. Does the Interim Reciprocal Travel Program apply to former American Airlines employees (not retirees) that are also Sabre retirees?

Former American employees who are also Sabre retirees are not eligible for travel on US Airways or travel privileges on any other airline. Travel privileges for these employees are valid on any of the carriers in the AMR Network which presently includes American/American Eagle, SkyWest or ExpressJet flights marketed as American Eagle, and Chautauqua flights marketed as American Connection.
