On June 30, 2014, Allergan, Inc. ( Allergan ) issued a press release announcing updates to its research and development ( R&D ) pipeline and U.S. Food and Drug Administration approval of OZURDEX<sup>®</sup> (dexamethasone intravitreal implant) 0.7 mg as a treatment option for diabetic macular edema in certain patients. In addition, Allergan posted a presentation under the Investors section of its website with an R&D update on abicipar pegol (Anti-VEGF DARPin) and bimatoprost sustained-release implant for glaucoma.
