As of December 31, 2016, (i) 2,450,694 shares of Class B Common Stock, 67,615 shares of Class A Common Stock, and 733 shares of Class A Common Stock subject to restricted stock units that vest within 60 days of December 31, 2016 were held of record by Mr. McKelvey, and (ii) 21,876,096 shares of Class B Common Stock were held of record by the James McKelvey, Jr. Revocable Trust dated July 2, 2014, for which Mr. McKelvey serves as trustee.

Each share of Class B Common Stock is convertible into one share of Class A Common Stock at the option of the holder and has no expiration date. The rights of the holders of Class A Common Stock and Class B Common Stock are identical, except with respect to the aforementioned conversion rights and voting rights. Each share of Class B Common Stock is entitled to ten votes per share, whereas each share of Class A Common Stock is entitled to one vote per share.

(b) Percent of class:

The ownership percentage above is calculated based on 198,746,620 shares of Class A Common Stock outstanding as of December 31, 2016, as reported by the issuer to the reporting person, plus the assumed conversion of 24,326,790 shares of Class B Common Stock deemed beneficially owned by Mr. McKelvey, as described herein, into shares of Class A Common Stock.
