Item 3.03. Material Modification to Rights of Security Holders.

On June 25, 2018, The J. M. Smucker Company (the <u>Company</u>) and Computershare Trust Company, N.A., as rights agent, entered into Amendment No. 3 to the Rights Agreement, dated as of May 20, 2009, and subsequently amended as of February 3, 2015 and October 24, 2016 (as amended, the <u>Rights Agreement</u>). Amendment No. 3 accelerates the expiration of the rights to purchase preferred shares (the <u>Rights</u>) under the Rights Agreement from June 2, 2019 to June 25, 2018, and has the effect of terminating the Rights Agreement on that date. At the time of the termination of the Rights Agreement, all of the Rights distributed to holders of the Company s common shares pursuant to the Rights Agreement will expire.
