Description of Terms

Linked to the S&P 500[®] Index

Unlike ordinary debt securities, the securities do not pay interest or repay a fixed amount of principal at maturity. Instead, the securities provide for a maturity payment amount that may be greater than, equal to or less than the original offering price of the securities, depending on the performance of the Index from its starting level to its ending level. The maturity payment amount will reflect the following terms:

If the level of the Index increases:

You will receive the original offering price plus 150% participation in the upside performance of the Index, subject to a maximum return at maturity of 38% of the original offering price. As a result of the maximum return, the maximum maturity payment amount will be \$1,380.00.

If the level of the Index decreases but the decrease is not more than 30%:

You will be repaid the original offering price

If the level of the Index decreases by more than 30%:

You will have full downside exposure to the decrease in the level of the Index from the starting level, and you will lose more than 30%, and possibly all, of the original offering price of your securities

Investors may lose some, or all, of the original offering price

All payments on the securities are subject to the credit risk of Wells Fargo & Company, and you will have no ability to pursue any securities included in the Index for payment; if Wells Fargo & Company defaults on its obligations, you could lose some or all of your investment

How The Maturity Payment Amount Is Calculated

On the stated maturity date, you will receive a cash payment per security equal to the maturity payment amount. The maturity payment amount per security will equal:

If the ending level is greater than the starting level: \$1,000 *plus* the lesser of:

(i) $\$1,000 \times \frac{\text{ending level} - \text{starting level}}{\text{starting level}} \times \text{participation rate}$; rate

(ii) the maximum return;

If the ending level is less than or equal to the starting level, but greater than or equal to the threshold level: \$1,000;
or

If the ending level is less than the threshold level: \$1,000 *minus*

$$\$1,000 \times \frac{\text{starting level} - \text{ending level}}{\text{starting level}}$$
