On October 29, 2007, the Reporting Person was granted a stock option to purchase 75,000 shares of the Issuer's Common Stock, 25% of which vested one year from the grant date and the remaining 75% of the shares are scheduled to vest monthly over the next 36 months until the option is fully vested on the fourth anniversary of the grant date.
