- (1) On February 16, 2010, the Reporting Person was granted 1,500 stock units, 1/3 of which are scheduled to vest on each of the first, second and third anniversaries of the grant date.
- (2) On February 17, 2010, the Reporting Person vested as to 2,500 stock units; the Issuer withheld 683 shares of its Common Stock otherwise issuable to the Reporting Person in settlement of the vesting of these stock units to fulfill withholding tax obligations.
