(a) On May 13, 2010, Nareshkumer H. Arora CPA ( Arora ) resigned as WWA Group, Inc. s (the Company )

The reports of Arora on the consolidated financial statements of the Company as of and for the years ended December 31, 2009 and 2008 did not contain an adverse opinion or disclaimer of opinion, nor were they qualified or modified as to uncertainty, audit scope, or accounting principles.

Between April 29, 2009 (the date of engagement) and May 13, 2010 (the date of resignation) there were no disagreements with Arora on any matter of accounting principles or practices, financial statement disclosure, or auditing scope or procedure, which disagreements, if not resolved to the satisfaction of Arora, would have caused Arora to make reference to the subject matter of the disagreement in its review of the Company s consolidated financial statements for the years ended December 31, 2008 and 2009.

The Company has requested that Arora furnish it with a letter addressed to the Securities and Exchange Commission stating whether or not it agrees with the above statements. No such letter has been received from Arora by the Company to date.

(b) On May 13, 2010, upon the authorization and approval of the board of directors, the Company engaged Konstandinos Jerry Georgatos, Certified Public Accountant ( Georgatos ) as its independent registered public accounting firm.

No consultations occurred between the Company and Georgatos during the years ended December 31, 2009 and 2008 and through May 13, 2010, regarding either (i) the application of accounting principles to a specific completed or contemplated transaction, the type of audit opinion that might be rendered on the Company s financial statements, or other information provided that was an important factor considered by the Company in reaching a decision as to an accounting, auditing, or financial reporting issue, or (ii) any matter that was the subject of disagreement requiring disclosure under Item 304(a)(1)(iv) of Regulation S-K or reportable event requiring disclosure under Item 304(a)(1)(v) of Regulation S-K.
