Pursuant to the terms of an asset purchase agreement entered into and previously disclosed by Corinthian Colleges, Inc. (the "Company"), effective February 29, 2008 the Company completed the sale of its 12 Canadian schools located outside the province of Ontario to a wholly-owned subsidiary of the Eminata Group, for a cash payment of CAD \$3,022,000. This payment consists of the purchase price of \$7.4 million less preliminary negative working capital and other adjustments equal to \$4,378,000. This cash payment is subject to a final working capital adjustment that will be made within approximately 90 days after the closing.
