- (1) This transaction involved gifts of securities to the trusts of five individuals outside of Mr. Horton's household and is being voluntarily disclosed on this Form 4. Mr. Horton disclaims beneficial ownership of the shares gifted.

- (3) These shares were surrendered to issuer to cover tax obligations of the 27,675 shares of DHI common stock issued upon the vesting of the restricted stock units awarded February 12, 2016.
- (4) On February 12, 2016, the reporting person was granted 94,000 restricted stock units, vesting in three annual installments beginning February 12, 2017.
