Elliott Associates individually beneficially owns 5,054,173 shares of Class A Common Stock, including 5,027,660 shares of Class A Common Stock through The Liverpool Limited Partnership, a Bermuda limited partnership that is a wholly-owned subsidiary of Elliott Associates (“Liverpool”).

Elliott International and International Advisors together beneficially own the 10,739,959 shares of Class A Common Stock held by Spraberry Investments Inc., a Delaware corporation that is a wholly-owned subsidiary of Elliott International (“Spraberry”).

Elliott Associates, Elliott International and International Advisors together beneficially own an aggregate of 15,794,132 shares of Class A Common Stock.

(b) Percent of class:

The aggregate percentage of Class A Common Stock reported owned by each person named herein is based upon 152,539,532 shares of Class A Common Stock outstanding as of November 9, 2018, as reported in the Issuer’s Quarterly Report on Form 10-Q for the quarterly period ended September 30, 2018, filed with the Securities and Exchange Commission on November 13, 2018.

Elliott Associates beneficially owned approximately 3.3% of the outstanding shares of Class A Common Stock.

Elliott International and International Advisors owned approximately 7.0% of the outstanding shares of the Class A Common Stock.

Elliott Associates, Elliott International and International Advisors’ aggregate beneficial ownership constituted approximately 10.4% of the outstanding shares of Class A Common Stock.
