This Form 4 reports the grant of 8,750 shares of restricted stock under the Spartan Stores, Inc. 2001 Stock Incentive Plan ("Plan"). These shares will vest at the rate of 20% per year beginning on October 1, 2007, and will be fully vested on October 1, 2011.
