#### (d) Appointment of New Directors

On April 2, 2019, First Financial Northwest, Inc. (the "Company"), its financial institution subsidiary, First Financial Northwest Bank ("Bank"), and its non-financial institution subsidiary, First Financial Diversified Corporation ("FFD"), announced that their Boards of Directors had appointed Ms. Patricia M. Remch to their respective Boards of Directors effective April 1, 2019. The appointment of Ms. Remch as a Director of the Company, the Bank and FFD was at the recommendation of each Board's nominating committee. Ms. Remch has not been appointed to serve on any of the Company's, Bank's or FFD's committees. Ms. Remch has not engaged in any transaction with the Company, the Bank or FFD that would be reportable as a related party transaction under the rules of the Securities and Exchange Commission.
