This Schedule 13G (this Schedule 13G) is being filed on behalf of Fir Tree Value Master Fund, L.P., a Cayman Islands exempted limited partnership (Fir Tree Value), and Fir Tree, Inc., a New York corporation (Fir Tree), relating to Class A Common Stock, \$.01 par value per share (the Common Stock) of Clear Channel Outdoor Holdings, Inc., a Delaware corporation (the Issuer), purchased by Fir Tree Value. Fir Tree is the investment manager of Fir Tree Value. Fir Tree Value and Fir Tree are collectively referred to as the Reporting Persons.

- (b) The Reporting Persons beneficially own 2,179,687 shares of Common Stock which represents 5.4% of the shares of Common Stock outstanding. This percentage is determined by dividing the number of shares beneficially held by the Reporting Persons by 40,676,720, the number of shares of Common Stock outstanding as of May 8, 2009, as reported in the Issuer's 10-Q filed with the Securities and Exchange Commission on May 11, 2009.
- (c) Fir Tree Value may direct the vote and disposition of 2,179,687 shares of Common Stock. Fir Tree has been granted investment discretion over the Common Stock held by Fir Tree Value.
