All of the foregoing shares are held directly by SF Capital Partners, Ltd., a British Virgin Islands company ("SF Capital"). The Reporting Persons are the founding members and direct the management of Staro Asset Management, L.L.C., a Wisconsin limited liability company ("Staro") which acts as investment manager and has sole power to direct the management of SF Capital. Through Staro, the Reporting Persons possess sole voting and dispositive power over all of the shares reported herein. Based upon the 34,172,021 shares of Common Stock issued and outstanding as of October 31, 2003 (as set forth in the Issuer's quarterly report on Form 10-Q for the fiscal quarter ended September 30, 2003), for the purposes of Rule 13d-3 under the Securities Exchange Act of 1934, the Reporting Persons may be deemed to be the beneficial owners of 2,818,876 shares of Common Stock which represents 8.2% of the Issuer's issued and outstanding shares of Common Stock. The beneficial ownership of the Reporting Persons excludes certain shares of Common Stock that may become issuable pursuant to warrants issued to SF Capital. Such warrants issued to SF Capital contain exercise caps which prohibit the holder (and its affiliates) of the warrants from exercising such warrants to the extent that giving effect to

such exercise, such holder would beneficially own in excess of 4.999% and 9.999% of the Issuer's outstanding Common Stock.
